ORDER

On July 6, 2020, Green River Valley Water District (Green River Valley District) filed a motion for an extension of time to file its response to Commission Staff's fifth request for information (Response to Staff's Fifth Request). In support of its motion, Green River Valley District states Staff's Fifth Request allows only seven business days in which to compile the requested information, and in addition to responding to Staff's Fifth Request in this proceeding, Green River Valley District must prepare a response to Commission Staff's request for information in Case no. 2020-00085. Green River Valley District further states that it's General Manager will have limited availability for the next 14 days due to medical issues, and it has a limited number of employees who are sufficiently familiar with its record systems and practices to compile the requested information and prepare Green River Valley District's response. Green River Valley District requests an extension of time until July 24, 2020, to file its Response to Staff's Fifth Request.

Having considered Green River Valley District's motion and being otherwise sufficiently advised, the Commission finds good cause to grant Green River Valley District's motion and to allow for an extension of time to July 24, 2020, to file its Response

to Staff's Fifth Request, conditioned upon Green River Valley District not placing the proposed tariff provisions, which are the subject of this proceeding into effect until the Commission issues a final Order in this proceeding.

- 2. Green River Valley District's Response to Staff's Fifth Request shall be filed on or before July 24, 2020.
