ORDER

On April 16, 2020, the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General), filed a motion requesting Commission approval to replace supplemental data requests filed on April 15, 2020, which inadvertently contained material for which a confidentiality motion is pending.

Based upon a review of the motion and supplemental data requests, the Commission finds that the Attorney General established good cause to replace the supplemental data requests, and therefore the motion should be granted.
