ORDER

On March 30, 2020, Atmos Energy Corporation (Atmos) filed its Gas Cost Adjustment (GCA) to be effective May 1, 2020.

After reviewing the record in this case, and being otherwise sufficiently advised, the Commission finds that:

1. Atmos's report includes revised rates designed to pass on to its sales customers its expected change in wholesale gas costs.
2. Atmos's Expected Gas Cost (EGC) for firm sales customers is \$3.5179 per Mcf, which is a decrease of \$.3923 per Mcf from the previous EGC of \$3.9102 per Mcf. Atmos's EGC for interruptible sales customers is \$2.2647 per Mcf, which is a decrease of \$.3923 per Mcf from the previous EGC of \$2.6570 per Mcf.
3. Atmos's report sets out no Refund Factor.
4. Atmos's report sets out a Correction Factor (CF) of (\$.2825) per Mcf, which is an increase of \$.0105 per Mcf from its previous CF of (\$.2930) per Mcf.
5. Atmos's report sets out a Performance-Based Rate Recovery Factor (PBRRF) of \$.2169 per Mcf.
6. Atmos's GCAs are \$3.4523 per Mcf for firm sales customers and \$2.1991 per Mcf for interruptible sales customers. The impact on firm sales customers is a

decrease of \$.3818 per Mcf from the previous GCA of \$3.8341 per Mcf. The impact on interruptible sales customers is a decrease of \$.3818 per Mcf from the previous GCA of \$2.5809 per Mcf.

7. Should Atmos purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports then the supplier, cost, and amount must be documented in its cover letter to the Commission.

8. The rates proposed by Atmos and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for final meter readings by Atmos on and after May 1, 2020.

IT IS THEREFORE ORDERED that:

1. The rates set forth in the Appendix to this Order are approved for final meter readings on and after May 1, 2020.

2. Within 20 days of the date of the entry of this Order, Atmos shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.

3. This case is closed and removed from the Commission's docket.

The following rates and charges are prescribed for the customers in the area served by Atmos Energy Corporation. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under the authority of the Commission prior to the effective date of this Order.

RATES:

Applicable to General Sales Service Rate G-1:

Gas Cost Adjustment

To each bill rendered under the above-named rate schedule, there shall be added an amount equal to \$3.4523 per Mcf of gas used during the billing period.

Applicable to Interruptible Sales Service Rate G-2:

Gas Cost Adjustment

To each bill rendered under the above-named rate schedule, there shall be added an amount equal to \$2.1991 per Mcf of gas used during the billing period.
