<u>ORDER</u>

On May 4, 2020, East Daviess County Water Association, Inc. (East Daviess Water) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

Having reviewed the record and being otherwise sufficiently advised, the Commission finds that:

 East Daviess Water purchases water from Owensboro Municipal Utilities (OMU).

2. OMU notified East Daviess Water that its wholesale rate would increase from \$1.63 per 1,000 gallons to \$1.94 per 1,000 gallons effective June 1, 2020. East Daviess Water proposes to increase the water rates to its customers effective June 1, 2020, to reflect the increased cost of purchased water from OMU.

3. East Daviess Water proposed a purchased water adjustment factor of \$0.38 per 1,000 gallons in its application.

4. During the 12 months ended March 31, 2020, East Daviess Water purchased 303,703,600 gallons of water from OMU. During the same period, East

Daviess Water sold 247,905,411 gallons of water. The increase in the cost of purchased water is \$94,148.11, resulting in a purchased water adjustment factor of \$0.38 per 1,000 gallons.

5. The purchased water adjustment factor of \$0.38 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.

6. East Daviess Water's proposed rates should be approved.

7. The rates as set forth in Appendix B to this Order are fair, just, and reasonable and should be approved for water service rendered by East Daviess Water on and after June 1, 2020.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment factor of \$0.38 per 1,000 gallons is approved.

2. The rates proposed by East Daviess Water are approved.

3. The rates as set forth in Appendix B to this Order are approved for water service rendered by East Daviess Water on and after June 1, 2020.

4. Within 20 days of the date of entry of this Order, East Daviess Water shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.

5. This case is closed and removed from the Commission's docket.
