ORDER

On May 29, 2020, Western Lewis-Rectorville Water and Gas District (Western Lewis-Rectorville District) filed its proposed Gas Cost Recovery (GCR) rate to be effective July 1, 2020. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Western Lewis-Rectorville District's report includes revised rates designed to pass on to its customers its expected change in gas costs.
- Western Lewis-Rectorville District's report sets out an Expected Gas Cost (EGC) of \$3.0035 per Mcf, which is an increase of \$.1980 per Mcf from its previous EGC of \$2.8055 per Mcf.
- 3. Western Lewis-Rectorville District's report sets out a Refund Adjustment (RA) of (\$1.2500) per Mcf.
- 4. Western Lewis-Rectorville District's report sets out a current quarter Actual Adjustment (AA) of \$.0879 per Mcf. In calculating its total AA, Western Lewis-Rectorville District failed to include the second previous quarter AA of (\$.0371) per Mcf that was

approved in Case No. 2019-00438.¹ Correcting this produces a total AA of (\$.1245) per Mcf, which is an increase of \$.5706 per Mcf from its previous total AA of (\$.6951) per Mcf.

- 5. Western Lewis-Rectorville District's report sets out no Balance Adjustment.
- 6. Western Lewis-Rectorville District's corrected GCR rate is \$1.6290 per Mcf, which is an increase of \$.7686 per Mcf from the previous GCR rate of \$.8604 per Mcf.
- 7. The rates as set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Western Lewis-Rectorville District on and after July 1, 2020.
- 8. Should Western Lewis-Rectorville District purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports, then the supplier, cost, and amount must be documented in its cover letter to the Commission.

IT IS THEREFORE ORDERED that:

- 1. The rates proposed by Western Lewis-Rectorville District are denied.
- 2. The rates set forth in the Appendix to this Order are approved for service rendered by Western Lewis-Rectorville District on and after July 1, 2020.
- 3. Within 20 days of the date of entry of this Order, Western Lewis-Rectorville District shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
 - 4. This case is closed and removed from the Commission's docket.
