ORDER

This matter is before the Commission upon a motion filed by the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General) to amend the procedural schedule. In support of the motion, the Attorney General states that the current procedural schedule, as established pursuant to the Commission's July 28, 2020 Order, provides for the filing of intervenor testimony on or before August 24, 2020. The Attorney General informs that he will not be filing intervenor testimony based upon a review of the discovery responses filed thus far in this matter. The Attorney General's decision to not file testimony will open up three weeks in the current procedural schedule. The Attorney General, therefore, requests that the procedural schedule be amended to provide for a second round of discovery upon the application of Big Rivers Electric Corporation (BREC) in order to obtain clarification on certain issues.

On August 24, 2020, BREC filed a response to the Attorney General's motion expressing no objections to the request to amend the procedural schedule. BREC requests that it be allowed at least 10 days to file its discovery responses to the additional

round of discovery and that the revised procedural schedule not negatively impact its request for a decision from the Commission by September 28, 2020.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that the Attorney General has established sufficient cause to permit a revision to the current procedural schedule.

IT IS HEREBY ORDERED that:

1. The Attorney General's motion to amend the procedural schedule is granted.
2. The procedural schedule established by the July 28, 2020 Order shall be amended.
3. The amended procedural schedule set forth in the Appendix to this Order shall be followed.
4. All other provisions of the July 28, 2020 Order shall remain in full force and effect.
