ORDER

On June 30, 2020, Peoples Gas KY, LLC (Peoples) filed its proposed Gas Cost Recovery (GCR) rate report to be August 1, 2020.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Peoples' GCR report includes a revised rate designed to pass on to its customers its expected change in gas costs.
2. Peoples' GCR report sets out an Expected Gas Cost (EGC) of \$2.4533 per Mcf, which is a decrease of \$.1196 per Mcf from its previous EGC of \$2.5729 per Mcf.
3. Peoples' GCR report sets out no Refund Adjustment.
4. Peoples' GCR report sets out a current quarter Actual Cost Adjustment (ACA) of \$.0875 per Mcf. Peoples' total ACA is (\$.4097) per Mcf, which is an increase of \$.3903 per Mcf from the previous total ACA of (\$.8000) per Mcf.
5. Peoples' GCR report sets out a current quarter Balance Adjustment (BA) of \$.0049 per Mcf. Peoples' total BA is \$.0574 per Mcf, which is a decrease of \$.0106 per Mcf from the previous total BA of \$.0680 per Mcf.

6. Peoples' GCR rate is \$2.1010 per Mcf, which is an increase of \$.2601 per Mcf from its previous rate of \$1.8409 per Mcf.

7. Should Peoples purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports then the supplier, cost, and amount must be documented in its cover letter to the Commission.

8. The rate as proposed by Peoples and set forth in the Appendix to this Order is fair, just, and reasonable and should be approved for final meter readings by Peoples on and after August 1, 2020.

IT IS THEREFORE ORDERED that:

1. The rate proposed by Peoples and set forth in the Appendix to this Order is approved for final meter readings on and after August 1, 2020.

2. Within 20 days of the date of entry of this Order, Peoples shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order.

3. This case is closed and removed from the Commission's docket.
