<u>ORDER</u>

On September 18, 2020, Kenergy Corp. (Kenergy) filed a motion requesting that the Commission reinstate the procedural schedule. Kenergy's motion did not specifically refer to the procedural schedule issued by Order of the Commission on August 5, 2020, the procedural dates of which have already past. Therefore reinstating the August 5, 2020 procedural schedule is not possible. The Commission also notes that at the time the procedural schedule was placed in abeyance,¹ the next procedural event was a request for information scheduled to be issued on September 10, 2020.² Finally, the Commission notes that in support of its motion, Kenergy stated, for the first time this proceeding, that it requires a decision from the Commission by October 23, 2020, to proceed with its project.

Based upon a review of the motion, and being otherwise sufficiently advised, the Commission finds that Kenergy's motion should be denied. The Commission further finds that establishing a procedural schedule to complete its orderly review of this matter is

necessary. The Commission finds that the only remaining procedural events should be the following:

Based upon the foregoing IT IS THEREFORE ORDERED that:

- 1. Kenergy's motion to reinstate procedural schedule is denied.
- 2. No later than October 1, 2020, parties may file a request for a hearing.
- 3. No later than October 8, 2020, parties may submit simultaneous Briefs on the issues, accompanied by a request for a decision based on the record.
 - 4. Parties shall follow the procedural schedule established in this Order.
