ORDER

On January 15, 2026, Farmdale Water District (Farmdale District) filed a motion to close this proceeding and for relief from further reporting obligations (Motion).

DISCUSSION AND FINDINGS

On July 7, 2020, the Commission issued an Order opening this case to monitor the water loss surcharge granted in Case No. 2020-00021,<sup>1</sup> and stated Farmdale District should be authorized to assess a monthly surcharge of \$3 per customer for 48 months, or until \$380,000 has been assessed, whichever occurs first.<sup>2</sup>

Farmdale District assessed its water loss surcharge beginning August 27, 2020, and continued to bill its customers for the surcharge through July 11, 2024, a period of 48 months.<sup>3</sup> On July 26, 2024, Farmdale District notified the Commission that it had ceased assessing the surcharge,<sup>4</sup> and by Order issued October 24, 2024, the Commission

granted approval of Farmdale District's cessation of its surcharge collections. Additionally, the Commission found that Farmdale District had complied with the July 7, 2020 Order by not exceeding the allowed \$380,000 collection amount.<sup>5</sup>

On January 23, 2025, the Commission entered an Order that, among other things, approved the use of surcharge funds to purchase meters and transceiver units.<sup>6</sup> On August 6, 2025, the Commission further approved Farmdale District's request to apply all surcharge funds remaining after the purchase of meters toward the purchase of transceivers from the Frankfort Plant Board.<sup>7</sup> As of January 14, 2026, Farmdale District's Monthly Activity Report with the Commission reflected it had exhausted all remaining funds in the surcharge account toward transceivers from the Frankfort Plant Board and indicated the surcharge account had been closed.<sup>8</sup>

Farmdale District has since continued to file Monthly Water Loss Reports and Monthly Surcharge Activity Reports, pursuant to the reporting requirements in the July 7, 2020 Order.<sup>9</sup>

The Commission finds that Farmdale District's Motion should be granted. Farmdale District has met its reporting requirements, has now fully exhausted the surcharge funds toward Commission approved expenditures, and should be released from the reporting requirements in this case.


