ORDER

On September 24, 2021, the Commission issued an Order in this case, pursuant to KRS 278.650, scheduling the local public hearing. The Order mistakenly omitted Vertical Bridge Development, LLC as one of the applicants in this case.

Finding that the September 24, 2021 Order should be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. The first sentence of the September 24, 2021 Order is stricken and is replaced with the following language:

On September 15, 2020, Vertical Bridge Development, LLC (Vertical Bridge) and New Cingular Wireless PCS, LLC d/b/a AT&T Mobility (AT&T Mobility) filed an application seeking a Certificate of Public Convenience and Necessity (CPCN) to construct and operate a wireless telecommunications facility in Graves County, Kentucky.

2. The second sentence of the September 24, 2021 Order is stricken and is replaced with the following language:

Because more than three residents have requested a local public hearing on Vertical Bridge's and AT&T Mobility's

application for a CPCN, the Commission, pursuant to KRS 278.650, must convene a local public hearing.

3. All other provisions of the Commission's September 24, 2021 Order that are not in conflict with the terms of this Order shall remain in effect.
