### ORDER

On August 20, 2020, Martin Gas, Inc. (Martin) filed its proposed Gas Cost Recovery (GCR) rate report to be effective October 1, 2020. Martin's previous GCR rate was approved in Case No. 2020-00180.<sup>1</sup>

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Martin's report includes revised rates designed to pass on to its customers its expected change in gas costs.
- 2. Martin's report sets out an Expected Gas Cost (EGC) of \$ 4.9549 per Mcf, which is a decrease of \$.0532 per Mcf from its previous EGC of \$5.0081 per Mcf.
  - 3. Martin's report sets out no supplier Refund Adjustment.
- 4. Martin's report sets out a current quarter Actual Adjustment (AA) of (\$.1692) per Mcf. Martin's total AA is (\$.3481) per Mcf, which is a decrease of \$.1462 per Mcf from its previous total AA of (\$.2019) per Mcf.
  - 5. Martin's report sets out no Balance Adjustment.

- 6. Martin's report sets out a GCR rate of \$4.6068 per Mcf, which is a decrease of \$.1994 per Mcf from the previous GCR rate of \$4.8063 per Mcf.
- 7. The rates set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Martin on and after October 1, 2020.
- 8. Should Martin purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports, then the supplier, cost, and amount must be documented in its cover letter to the Commission.

### IT IS THEREFORE ORDERED that:

- 1. The rates proposed by Martin and set forth in the Appendix to this Order are approved for service rendered on and after October 1, 2020.
- 2. Within 20 days of the date of entry of this Order, Martin shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
  - This case is closed and removed from the Commission's docket.
