ORDER

This matter arises upon the motion of Sierra Club, filed February 5, 2021, for full intervention. Sierra Club's motion states that it seeks to intervene to represent the interests of residential customers of Big Rivers Electric Corporation (BREC), including Ben Taylor, a Sierra Club member and customer of Kenergy Corp., which is a distribution cooperative of BREC. It appears to the Commission that such intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. The Commission, being otherwise sufficiently advised, finds that Sierra Club should be granted full rights of a party in this proceeding.

IT IS HEREBY ORDERED that:

1. The motion of Sierra Club to intervene is granted.
2. Sierra Club shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.
3. Sierra Club shall comply with all provisions of the Commission's regulations, 807 KAR 5:001, Section 8, related to the service and electronic filing of documents.

4. Sierra Club shall adhere to the procedural schedule set forth in the Commission's January 12, 2021 Order and as amended by subsequent Orders.

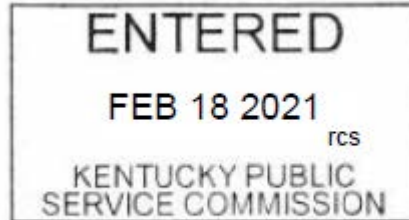
5. Pursuant to 807 KAR 5:001, Section 8(9), within seven days of entry of this Order, Sierra Club shall file a written statement with the Commission that:

a. Certifies that it, or its agent, possesses the facilities to receive electronic transmissions; and
