ORDER

On November 5, 2021, Sierra Club and the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General), filed separate motions requesting leave to participate in the November 23, 2021 hearing virtually. Sierra Club cites the risk of COVID-19 exposure and notes that it has participated in other Commission hearings virtually without incident. The Attorney General raised similar concerns and noted that neither Sierra Club nor Big Rivers Electric Corporation objected to their virtual participation. Neither Sierra Club nor the Attorney General presented witnesses in this matter. Having reviewed Sierra Club and the Attorney General's motions and being otherwise sufficiently advised, the Commission finds that there is good cause to grant Sierra Club or the Attorney General's motions to allow them to participate in the scheduled hearing virtually. Commission Staff will contact participants by electronic mail to provide details for joining the hearing by video link.

IT IS THEREFORE ORDERED that:

1. Sierra Club and the Attorney General's motions are granted.
2. Sierra Club and the Attorney General may participate in the November 23, 2021 hearing in this matter via video conference.

3. Commission Staff shall provide the parties with details for joining the hearing via video link.
