ORDER

This matter arises upon the motion of the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General), filed September 29, 2020, pursuant to KRS 367.150(8), for full intervention. Such intervention is authorized by statute. The Commission, being otherwise sufficiently advised, finds that the motion should be granted. The Commission directs the Attorney General to the Commission's March 16, 2020, and March 24, 2020 Orders in Case No. 2020-00085¹ regarding filings with the Commission. IT IS HEREBY ORDERED that:

- 1. The motion of the Attorney General to intervene is granted.
- 2. The Attorney General shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.
