ORDER

On March 4, 2026, Kentucky Power Company (Kentucky Power) filed a motion asking the Commission to issue an order amending the February 4, 2026 procedural schedule previously issued in this proceeding.¹ Kentucky Power stated that, because of the time between initial briefs and now and because of the changes in the legal framework and technologies associated with net metering, Kentucky Power requests that the Commission extend the deadlines in the procedural schedule by three weeks so that the deadline for filing supplemental briefing would be April 6, 2026, and the deadline to request a public hearing or submit a request for the matter to be decided based on the written record would be April 20, 2026.²

On March 6, 2026, East Kentucky Power Cooperative, Inc. (EKPC) filed a response to Kentucky Power's motion to amend the procedural schedule. EKPC stated that it does not oppose Kentucky Power's request to amend the procedural schedule so that the date for filing supplemental briefing would be April 6, 2026.³ EKPC requested

the Commission include a date for response briefs, if any party feels a response brief is necessary, on April 20, 2026. On March 9, 2026, Duke Energy Kentucky, Inc. filed a response to Kentucky Power's motion to amend the procedure schedule, stating it did not oppose the motion.⁴

Having considered the record and being otherwise sufficiently advised, the Commission finds that Kentucky Power's request to amend the procedural schedule should be granted. The Commission also finds that EKPC's request for responsive briefs should be granted. The amended procedural schedule as set forth below should be followed.

IT IS THEREFORE ORDERED that:

1. Kentucky Power's request to amend the procedural schedule is granted.
2. EKPC's request for responsive briefs is granted.
3. The procedural schedule established on February 4, 2026, is amended.
4. Parties, should they choose to do so, shall file any supplemental briefings by April 6, 2026.
5. Parties, should they choose to do so, shall file responsive briefs by April 20, 2026.
6. The last day for parties to request a public hearing or submit a request for the matter to be decided based upon the written record is April 23, 2026.
7. All provisions of the Commission's September 23, 2024 Order that are in conflict with the provisions of this Order are vacated, and all other provisions not in conflict with the provisions of this Order shall remain in effect.
