ORDER

On September 29, 2020, Navitas KY NG, LLC (Navitas KY) filed its proposed Gas Cost Recovery (GCR) rate report to be effective November 1, 2020. Navitas KY's previous GCR rate was approved in Case No. 2020-00200.¹

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that:

- 1. Navitas KY's report includes revised rates designed to pass on to its customers its expected change in gas costs.
- 2. Navitas KY's report sets out an Expected Gas Cost (EGC) of \$6.9712 per Mcf, which is a decrease of \$.1797 per Mcf from its previous EGC of \$7.1509 per Mcf.
 - 3. Navitas KY's report sets out no Refund Adjustment.
- 4. Navitas KY's report sets out a current quarter Actual Adjustment Calculations (ACA) of \$.0884 per Mcf. Navitas KY's total ACA is \$.8425 per Mcf, which is an increase of \$.2272 per Mcf from its previous total ACA of \$.6153 per Mcf.

- 5. Navitas KY's report sets out a current quarter Balance Adjustment (BA) of \$.0176 per Mcf. Navitas KY's total BA is \$.0888 per Mcf, which is a decrease of \$.0299 per Mcf from its previous total BA of \$.1187 per Mcf.
- 6. Navitas KY's GCR rate is \$7.9025 per Mcf, which is an increase of \$.0176 per Mcf from its previous GCR rate of \$7.8849 per Mcf.
- 7. The rate set forth in the Appendix to this Order is fair, just, and reasonable, and should be approved for service rendered by Navitas KY on and after November 1, 2020.

IT IS THEREFORE ORDERED that:

- 1. The rate set forth in the Appendix to this Order is approved for service rendered by Navitas KY on and after November 1, 2020.
- 2. Within 20 days of the date of entry of this Order, Navitas KY shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order.
 - This case is closed and removed from the Commission's docket.
