ORDER

On December 16, 2020, New Cingular Wireless PCS, LLC d/b/a AT&T Mobility (AT&T Mobility) filed an application seeking a Certificate of Public Convenience and Necessity (CPCN) to construct and operate a wireless telecommunications facility in Wayne County, Kentucky. More than three residents of Wayne County have requested that the Commission convene a local public hearing. Because more than three residents have requested a local public hearing on AT&T Mobility's application for a CPCN, the Commission, pursuant to KRS 278.650, must convene a local public hearing.

IT IS THEREFORE ORDERED that:

- 1. A local public hearing is convened for the purpose of taking public comment on AT&T Mobility's application for a CPCN to construct a wireless telecommunications facility to be located at 152 Arlie Piercy Road, Monticello, Kentucky 42633.
- 2. The local public hearing shall be held on October 1, 2021, at 150 Cardinal Way, Monticello, Kentucky 42633 and shall begin at 4 p.m. Eastern Daylight Time.
 - 3. No evidence shall be taken at the local public hearing.

- 4. AT&T Mobility shall have a representative present at the local public hearing to answer questions from the public.
- 5. AT&T Mobility shall provide written notice of the time and place of the local public hearing to the residents of Wayne County that requested the local public hearing, and to the Wayne County Judge Executive.
