ORDER

On January 25, 2021, Southern Madison Water District (Southern Madison District) filed an answer to the complaint filed by Judy Keith and a motion to dismiss Ms. Keith's complaint.

The Commission finds that Ms. Keith should file a response to Southern Madison District's motion to dismiss. In the response, Ms. Keith should state whether she disputes the accuracy of the history provided by Southern Madison District.

The Commission directs Ms. Keith to the March 16, 2020 and March 24, 2020 Orders in Case No. 2020-00085¹ regarding the filing of physical documents with the Commission. In the March 16, 2020 Order, the Commission stated that if a nonelectronic case is not converted to an electronic case, the Commission will grant a deviation from the filing requirements 807 KAR 5:001, Section 7(1), insofar that a filer may file one

original document with no copies or send an electronic mail message with an electronic copy of the document to the Commission and to parties to the matter. The Commission expects that original documents will be filed with the Commission within 30 days of the lifting of the current state of emergency. Any electronic email filed in this manner should be sent to PSCED@ky.gov,² and each message should include the case number in the subject line of the message and a read receipt to ensure the Commission received the message and documents. A party filing a paper containing personal information shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

IT IS THEREFORE ORDERED that Ms. Keith shall file a response to Southern Madison District's motion to dismiss within seven days of service of this Order.
