Hi Quang,

I hope you're doing well today. Following up from our site visit on 6/11, I wanted to provide you answers to a few of your questions regarding Silicon Ranch's Regenerative Energy initiative that will be deployed at Turkey Creek Solar.

I believe your questions were 1) How does SRC qualify ranchers? 2) Are local ranchers used when possible? 3) How does a rancher get the training needed for the Regenerative Energy standard?

In general, Regenerative Energy Land Managers have experience in land management and animal husbandry, with the ability to offer an integrated land management service – sheep grazing, mowing and weed whipping as needed.

SRC recruits and contracts ranching venders on a project by project basis. In areas where SRC has clusters of projects, a rancher may manage multiple projects.

A prerequisite for ranchers is the use of **rotational grazing practices** with sheep on their home ranch or farm.

Local ranchers are given preference, but more importantly, a rancher must exhibit the ability to manage large tracts of land using rotational grazing and mechanical tools, and meet our insurance requirements. At times ranchers from the greater region are hired if a qualified rancher cannot be found, however, they are encouraged to hire and train local ranchers for day-to-day tasks.

SRC is currently developing a training program for qualified ranchers, to learn the nuances of solar grazing projects. Likely, SRC will start this in 2021.

Additionally, Commissioner Matthews requested a site visit to an operating Silicon Ranch Regenerative Energy project. The closest project to Kentucky is in Millington, TN. If the PSC and staff members are interested in making this trip west, could you please provide a few dates that everyone is available? I will work internally to see which of the dates provided works best for our team.
