MERCHANT ELECTRIC GENERATING FACILITY**

Pursuant to KRS 278.706 and 807 KAR 5:110, Glover Creek Solar, LLC (“Glover Creek”), by counsel, submits this application for a construction certificate to construct a merchant electric generating facility. In support of this application, Glover Creek states as follows:

1. Glover Creek is a limited liability company organized under the laws of North Carolina with a principal place of business of 400 W. Main St., Suite 503, Durham, North Carolina 27701. Glover Creek’s phone number is (919) 682-6822. A copy of Glover Creek’s Certificate of Authority that is on file with the Kentucky Secretary of State’s office is submitted as Attachment I below.
2. The proposed Glover Creek Solar Facility will be a 55-megawatt alternating current (MWac) photovoltaic electricity generation facility. The project is to be located in Metcalfe County, at approximately 7449 Randolph-Summer Shade Road, Summer Shade, KY 42166. The power generated by the project will be sold on the open market through the existing transmission line that crosses the property.
