RE: Informal Conference of May 21, 2026

Pursuant to a Staff Notice issued on May 5, 2026, an informal conference (IC) was conducted on May 21, 2026. Attached is a copy of the attendance roster.

The purpose of the informal conference was to discuss information contained in the monthly packet prepared for the April 2026 Martin County Water District (Martin District) board meeting.

Martin District confirmed that Timothy Thoma resigned as Chairman of the Martin District Board of Commissioners (Board) as of April 23, 2026 and no new appointment has been made for his position. Martin District also confirmed that Nina McCoy's term as a board member had expired, and Norma McCormick has been appointed for that position. Commission Staff requested that Martin District use the Commission's online system to submit those changes to its Board.

Alliance Water Resources (Alliance) further confirmed that Colby May has been promoted to Regional Operations Manager and is currently the acting General Manager for Martin District. Commission Staff reminded Alliance and Martin District of the updated infrastructure plan, that is required to be filed within 120 days, pursuant to the Commission's Order issued April 8, 2026.

Alliance briefly discussed current ongoing projects in Martin District to replace pump stations, as well as service lines and main lines in high water loss zones in the district, to assist with water loss reduction efforts.

Commission Staff discussed topics for the next monthly IC, to include, but not limited to: any updates on funding through its administrator, FAHE; an overview on current capital projects; future planned capital projects once funding is available; and any plans for the use of funding to pay Martin District's debts, including the arrearage to Alliance.

There being no further discussion, the informal conference was then adjourned.
