State the nature of your concern: In reference to Case Nos. 2020-00206 and 2020-00370, I hereby make the following complaint. I live adjacent to the two above proposed solar projects. I am literally enclosed within the two projects listed and near the other projects in Mason County. I do not think that infrastructure problems have been taken into account if these two projects are approved for construction. My wife worked at the water utility that is our supply for the surrounding areas. The utility could not supply the residential areas with adequate water pressure when there were 3 or 4 major dairies in operation on these adjacent roads. It has been stated that these solar panels will have to be cleaned regularly with water. I don't know how many panels you can install on 1500 acres, but regardless when these panels are being cleaned I am assured that the surrounding residents will not have an adequate amount of pressure to supply and maintain the required water supply to them. The present utility infrastructure I am sure is not adequate. Also, we live on KY 559 (Convict Pike) which is a connector road for the surrounding roads where this solar station is located and is a small rural state road which is a high traffic area to and from Flemingsburg. Add in the traffic for the construction and maintenance for this project and the residents will only be above to travel at the projects mercy. The road infrastructure is not adequate for the added entrances for ingress and egress needed for the construction and future maintenance of these projects. I ask that their request for the permit of public convenience be denied and that the request for permission of setbacks from property lines be denied. Also, as for job creation, we have no one in our skilled in this area, there are no places to lodge in Fleming County and we don't produce solar panels so there would be no positive economic impact for Fleming County and they have stated that when completed they will only need 5-7 employees to maintain the project. This is not an economic boon to our local employment situation. Thank you for your attention to this matter. We do not want this power plant in our farming community.
