An informal conference (IC) was conducted by videoconference on September 11, 2020. Attached is a copy of the sign in sheet.

The purpose of the IC was to discuss Kenergy Corp.'s (Kenergy) application for a waiver pursuant to KRS 278.2219 and Kenergy's recent supplemental filings in response to information requests filed by Commission Staff (Staff) and the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General). The parties and Staff agreed that the procedural schedule should remain in abeyance at this time. Kenergy will file a motion for leave to file testimony. Following an Order of the Commission granting such leave, Kenergy will file direct testimony containing sufficient information and details about its proposed plan to offer broadband internet service to its members via an affiliated subsidiary.

There being no further discussion, the IC was then adjourned.
