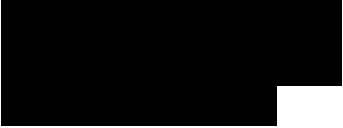

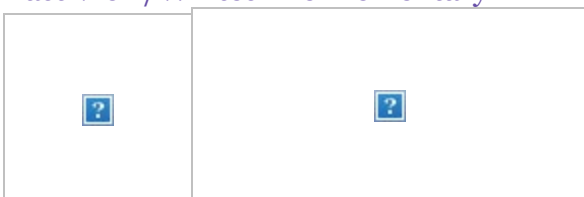

I can't even get Spectrum engineers to return my calls, and probably could not afford their installation fees living on a fixed income.

My current and only available service is with a wireless provider based in Indiana with an antenna many miles away. Living on the top of a hill, I have to have my receiver antenna over 40 feet in the air. Download Service is spotty at best, very slow and upload service is nearly nonexistent. Even my adult children and grandkids are hesitant to visit for long because of the need to run businesses and other on-line activities.

I recently taught a MS TEAMS class to an international group, and was extremely embarrassed that none of my prepared work would upload. We had to cancel in the middle of the session when no one could see even simple slides. Later classes had to be done from a neighbors home to have the bandwidth.

For my farm to thrive, for my safety as a senior living alone I wish for the simple ability to have enough bandwidth for security cameras, and perhaps online communication with my family, friends and first responders.
