1015 Otter Lake Loop, Hanson, KY 42413
Internet has been a challenge to get since the day we moved here. My husband is a physician at Baptist Health and relies on the internet to check the fetal monitoring of the mothers in labor from home. My son attends college online, my other son and daughter are online at a private school and must have internet for their live classes. I as well, am taking online college courses. We have tried Hughes Net and it did not work. We were paying \$185 a month. It caused huge problems for all of us in completing our school assignments. About a year ago we switched to Unlimitedville. It is \$200 a month, unlimited usage, and the device was in addition to the monthly service charge \$250 to purchase. It runs speeds of 7-10 still causing problems, so a friend told us about the Orbi system that we purchased at Costco for \$430 to use with it and that helps our speeds get up to 15-20. With these combined we are able to attend live

classes, search the internet, do gaming and streaming.

Our family would much appreciate your consideration to making better internet services available to the Otter Lake Area in Hanson, KY so we can continue to do our best in our professions and schooling.
