**Dear Ms. Bridwell:**

**An association of business located at the Triport/Delaplain Industrial Park in Scott County wishes to transmit this correspondence in order to request the Public Service Commission (PSC) to respond, prior to the ending of any public comment, to our concerns and questions relative to the newly requested rate increases by the Bluegrass Water Operating Company which is the new package treatment plant responsible for our business (es) location.**

**Our concerns are as follows:**

- 1. Companies in the affected Triport area did not receive any written or otherwise transmitted notice of a potential rate increase by the Bluegrass Water Operating Company. We assume the PSC requires such notice and a return receipt acknowledging delivery. Appropriate notification would have allowed us adequate time to document our concerns in the 'Public Comments' prior to the deadline for the closure of Public Comments and to request a meeting to discuss the actual details.**
- 2. While recognizing the potential need for capital investment to this treatment plant, we find it unreasonable to assume an expeditious return on investment; especially if the increase and repayment may result in a detrimental cost of doing business during the current COVID economy and the potential delay of our own capital investments. Amortization of the capital improvement should account for a reasonable time period**


