My name is Mrs. Charlotte Wells, mother of four, wife of Monte Wells, senior electrician at Wolf Creek Power Plant with the U.S. Army Corps of Engineers. Our address is 359 Raleigh Road, Science Hill, KY 42553. We are property owners also of 1891 Hwy. 2993, Nancy, KY 42544. My mother, Gladys Molden is the property owner on which the tower is to be built. My brother is Terry Molden. We all have invested interest in this property and the building of the tower. I am in favor of building the tower.

We are aware of the tower located nearby. We have no problem with this property owner having a tower on their property. We have always gotten along fine with our neighbors and respect their rights to do with their property as they see fit, as long as there is not illegal activity. We expect respect from our neighbors as well as to what goes on within the boundary lines of our private property.

As far as we know, when the nearby neighbor consented to have a tower placed on their property, there was no one roaming the community stirring up the neighbors against that private property owners wishes. We have heard of some going door to door looking for neighbors to sign against our wishes to have a tower built on our private property. This is appalling. This is infringing on our personal freedoms.

Our community is still free from home owner association type organizations. We do not want to be involved with those type of organizations as they limit private property owners in their personal choices of buildings, pets, etc. They are a threat to our American freedoms and we must defend our communities from that type of restriction. None of us want our personal freedoms restricted. The same goes for the choice to have a tower on our property. Others have been offered the choice to have a tower and have declined. That is their personal choice and we all respect that. It is their business.

We have also heard of some inquiring as to how much we were being paid!! We still have southern manners that respect what a neighbor makes whether it is on their business, job, private dealings, is none of our business. We feel our pay from a private contract concerning our private property is none of their business.

We have had too many freedoms in this country taken away already. If the landscape is a concern, I suggest a reminder of the freedoms we each have as private property owners to beautify our communities by planting your choice of height of trees, flowering bushes or hedges within your own boundaries of your property lines. There is lots of variety to choose from at your local stores to fit each need.
