I am writing to express concern over the approx. 10.7% increase in residential electric rates proposed by the Kentucky Utility Board (KUB). Those of us who are KUB customers in southeast Kentucky are struggling to just stay afloat. With the loss of the coal industry and its supporting industries, unemployment is at very high levels. We don't expect raises anymore, those of us with jobs are just happy to still be working. COVID impacts have further burdened our financial situation. Our older residents got a 1.3% increase in social security payments in 2021--for many of them, that increase will not even cover the increased cost of electricity proposed by KUB. Imposing the proposed 10.7% will make a very bad situation even worse here in southeast KY.

While other areas of the state may be faring much better than southeast KY, we are hurting. Please do not approve such a large increase in electric rates for our part of the state.
