Dear Sir or Madam,

I wanted to voice my opposition to the rate changes proposed by KU regarding home based solar systems.

I have a solar system on my home and it is working great. I'm encouraging my neighbors to install solar systems, especially those with all electric homes. The simplicity of grid tied systems is wonderful since there are no batteries to maintain. We are supplying renewable energy back onto the grid during peak usage hours so that KU does not need to generate as much power to supply the businesses that primarily consume during the daylight hours.

When KU exchanges power with producers like us, at the KWh for KWh rate, our home systems become financially feasible. I am able to recover my investment in seven to eight years and then reap the benefits of the solar system for the life of the system. If you allow KU to change to the \$0.02/KWh rate, then our system payback becomes 5 times longer 30 to 35

years and this makes installing home based solar systems non-feasible for homeowners. The life of a solar system is only 25 - 30 years. This will virtually end the most cost effective way to add renewable energy generation to KY.

I urge you, not to approve this aspect of their rate proposal and save the home energy solutions now available to homeowners.
