I wanted to share my opinion on the proposed LG&E rate increases. I am writing this with limited information - a 3 page notice to customers included with a recent bill. The proposed increase is 11.8% for electric and 9.4% for gas for the "average" customer.

1. The 3 page notice includes terminology and amounts that are not a part of my vocabulary. Hopefully the Commission is in a position to completely understand their proposal.
2. They frequently use the average customer definition. I find this disclosure very meaningless since our usage is significantly over average. Does that mean my increase will be double or triple of average? I'd like for the Commission to challenge the reasonableness of how they arrive at the average. It would be a lot more useful if they provided a range of results from low to high.
3. As indicated in #1, it was difficult to read this notice so I may have overlooked any reference to why they need this increase. What will they do with these additional revenues? Are these one off needs or ongoing needs that will be the base charge going forward?
4. How effective and efficient are they? When you see an LG&E truck in action, there always seems to be 1 digging and 4 or more standing around and watching. They appear to use a lot of contractors. Are these contractors providing the best service at the lowest bid cost without any related parties?

5. I am retired living on a fixed pension. Increases like the ones proposed makes me wonder how I will be able to stay in my house.

Bottom line, the proposed increases are outlandish and I am asking the Commission to take a very hard line on why there should be any increase. It is obvious that LG&E does not understand or care how the virus has impacted the economics of their average customer!
