In accordance with 807 KAR 5:001, Section 8, <u>McCreary County Water District</u> gives notice of its intent to file an application for certificate of public convenience and necessity and* with the Public Service Commission no later than <u>December 31, 2020</u> and to use the electronic filing procedures set forth in that regulation.
