Our county is one of the poorest in eastern Kentucky, yet our water and sewer rates exceed almost every county in the state. This is NOT ACCEPTABLE! We cannot continue to pay exorbitant bills

for the basic necessity of life.

Alliance Water Resources took over management of Martin County Water District, and since that time, they have continuously sought rate increases to "fix" the longstanding problems of our current water system. Why should the citizens of Martin County be expected to pay the salaries of Alliance Water employees through rate increases? If Alliance's expenses, which is the basis for their proposed rate increase, exceed their monthly income, then they should consider reducing the salaries of their employees.

I have worked since the age of 15, and am now 57, and am still employed on a full-time basis. My water and sewer bill that is due this month is over \$300.00 (I'm attaching a copy for your review). I have paid well over \$200/month for the past year. I've been a resident of Martin County my entire life, but I cannot continue to pay such high water and sewer bills. I have called the office of Martin County Water several times questioning my bill and am always told if they come out to test for leaks it would be at a cost to me.

I'm tired of sitting back and staying quiet. We, the citizens of Martin County, cannot afford another rate increase, and I beg you not to approve this proposed rate increase.
