Please allow Kenergy to provide high-speed broadband internet for rural Kentucky areas.

We are not offered high speed internet service except by using a mobile hotspot. My daughter is a freshman at Henderson County High School. Since schools are having NTI days, high speed internet is essential for participating and submitting school assignments. Education today is mostly performed electronically. Rural communities are at a big disadvantage in providing the ability for education to be performed at home.

As for allowing KBCA to intervene, all providers have had adequate time to step up and provide services for these areas. We have been told many times that just because where we live, there would not be enough customers signing on for service, they would not run lines down our road. There is service a mile and half down the road. However, with a lot of side roads, providers will not run service down these roads because it is not financially beneficial to them.

Allowing Kenergy to step in and provide these services will force the lame providers to increase services whether beneficial or not and make the market more competitive. But as of right now, many rural areas don't even have one service provider.

If the KBCA is allowed to intervene, their service maps should be looked at closely for <u>false</u> <u>information</u>. I have had them tell me on the service set up call, they do provide service to my area but when they get here, they tell me they don't.

Please find more accurate resources for service maps rather than using KBCA.

I'd like to make a few comments about the possibility of Kenergy Corporation providing internet access. I have a masters degree in Telecommunications Management and am a college professor teaching networking and telecommunications courses. In addition I have a Master Electrician License in Kentucky, am a Certified Fiber Optic Technician and have done network administration and project management around the state. Therefore I think I am uniquely qualified to speak on this topic.

If Kenergy is allowed to move into the ISP space it will be a boon not only for their customers but for the economy as a whole in the areas they serve. Many of their customers have no realistic options to get internet access at their homes. To prevent remedying this issue in this day and age is unconscionable and will relegate these customers to continuing living cut off from our increasingly connected world. It will prevent Kentuckiians from obtaining the increasing number of jobs that require working from home using reliable internet access. This, in turn, is detrimental to these rural economies as a whole.

While universal service guaranteed phone service to all Americans there is no such plan in place for internet access. Therefore no for-profit company is going to provide internet access where it is not profitable. This makes plans like the one Kenergy is attempting to put in place the only feasible way for many Kentuckians to gain access to the internet.

Even for Kenergy customers who have other options for internet access this is mostly provided by large companies whose customer service is horrible. Our entire economy is based on competition between businesses. Competition, though despised by those who hold effective monopolies, is vital to our economy and necessary to provide high quality customer service and reasonably priced internet access. If a company must resort to trying to get the Public Service Commission to prevent competition they have admitted that they either can't, or don't want to compete.

As I review the Public Service Commission's Mission and Purpose I see nothing about preventing Kentuckians from accessing the internet or preventing competition among internet service providers. I encourage you, in the strongest possible terms, to do the right thing and allow Kenergy's proposal to move forward.
