

We rely on our cell phones for work (we both work remotely), everyday calling and texting, and internet usage when our extremely limited internet options fail due to storms or power failures. We currently average 1 maybe 2 bars of coverage, and most times have to connect our cell phones to the wifi to make a phone call, as the lake area becomes more populated in the summer the coverage declines significantly creating a safety concern for my family and myself, as our ability to call 911 or other emergency services becomes limited. This also creates a concern with our ability to conduct everyday functions like making phone calls, and working- in 2023 this should not be an issue.
