O R D E R

On October 12, 2021, Inter-County Energy Cooperative Corporation (Inter-County Energy), pursuant to KRS 278.400, filed a motion requesting rehearing of the Prepay Service Energy Charge (Prepay Energy Charge) established by the Commission's September 30, 2021 Order.

In its motion, Inter-County Energy stated that an incorrect rate of \$0.09267 per kilowatt hour (kWh) was set forth in Appendix B to the September 30, 2021 Order for the Prepay Energy Charge amount. Inter-County Energy explained that the Prepay Energy Charge in Appendix B reflected the rate in effect prior to the September 30, 2021 Order, and was not updated to reflect the pass-through wholesale rate increase approved by the Commission. Inter-County Energy stated that the updated Prepay Energy Charge should have been \$0.09556 per kWh.

Based upon a review of the motion and Appendix B, the Commission finds that Appendix B contained an inadvertent error in the Prepay Energy Charge. The Commission further finds that Appendix B should be amended to replace the incorrect

Prepay Energy Charge of \$0.09267 per kWh with the correct Prepay Energy Charge of \$0.09556 per kWh.

IT IS THEREFORE ORDERED that:

1. Inter-County Energy's motion for rehearing is granted.
2. The Prepay Energy Charge in Appendix B to the September 30, 2021 Order

is stricken is replaced with the following language:

3. All other provisions of the Commission's September 30, 2021 Order that are not in conflict with the terms of this Order shall remain in effect.

4. This matter is closed and removed from the Commission's docket.
