ORDER

On March 25, 2021, the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General), filed a motion requesting that an informal conference be scheduled to discuss the availability of funds of offset storm-related expenses for which Kentucky Power requested a regulatory asset.

Based upon the motion, the Commission finds that the Attorney General established good cause and that an informal conference should be scheduled on March 26, 2021, at 2:30 p.m. Eastern Daylight Time, to take place via video conference link to

discuss availability of funds to off-set Kentucky Power's storm-related expenses and the proposed regulatory assets that are the subject of both of these cases.
