ORDER

On June 7, 2022, the Commission issued a final Order on rehearing in this proceeding. The Order included two appendices, Appendix A, which is a summary of Delta Natural Gas Company, Inc's (Delta) revenue requirement for the forecasted test year ended December 31, 2022, and Appendix B, which is the rate schedules approved in this proceeding. There is an error in Appendix B. In the column entitled "Total Rate" the customer charge for Small Non-Residential customers is shown as \$44.00. It should read "\$44.40." Additionally, the rate schedule did not include the rate charged to Delta's Farm Tap customers who were customers of the former Peoples Gas KY, LLC (Peoples).

Finding that the June 7, 2022 Order shall be amended, the Commission, HEREBY ORDERS, *nunc pro tunc*, that:

1. The rate schedule for Small Non-Residential customers that appears in Appendix B is stricken and replaced with the rate schedule for Small Non-Residential customers attached to this Order as an Appendix.

2. The rate schedule for Farm Tap customers that appears in Appendix B is stricken and replaced with the rate schedule for Farm Tap customers attached to this Order as an Appendix.

3. All provisions of the June 7, 2022 Order that are not in conflict with the terms of this Order shall remain in effect.


