# ORDER

On June 29, 2021, Atmos Energy Corporation (Atmos) filed its Gas Cost Adjustment (GCA) to be effective August 1, 2021. Atmos's previous GCA rate was approved in Case No. 2021-00142.<sup>1</sup>

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Atmos's report includes revised rates designed to pass on to its sales customers its expected change in wholesale gas costs.
- 2. Atmos's Expected Gas Cost (EGC) for firm sales customers is \$5.1641 per Mcf, which is an increase of \$.6830 per Mcf from the previous EGC of \$4.4811 per Mcf. Atmos's EGC for interruptible sales customers is \$3.8481 per Mcf, which is an increase of \$.6830 per Mcf from the previous EGC of \$3.1651 per Mcf.
  - 3. Atmos's report sets out no Refund Factor.
- 4. Atmos's report sets out a Correction Factor (CF) of (\$.3687) per Mcf, which is a decrease of \$.2486 per Mcf from its previous CF (\$.1201) per Mcf.

- 5. Atmos's report sets out a Performance-Based Rate Recovery Factor (PBRRF) of \$.1807 per Mcf.
- 6. Atmos's GCAs are \$4.9761 per Mcf for firm sales customers and \$3.6601 per Mcf for interruptible sales customers. The impact on firm sales customers is an increase of \$.4344 per Mcf from the previous GCA of \$4.5417 per Mcf. The impact on interruptible sales customers is an increase of \$.4344 per Mcf from the previous GCA of \$3.2257 per Mcf.
- 7. Should Atmos purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports then the supplier, cost, and amount must be documented in its cover letter to the Commission.
- 8. The rates proposed by Atmos and set forth in the Appendix to this Order are fair, just and reasonable and should be approved for final meter readings by Atmos on and after August 1, 2021.

#### IT IS THEREFORE ORDERED that:

- 1. The rates set forth in the Appendix to this Order are approved for final meter readings on and after August 1, 2021.
- 2. Within 20 days of the date of the entry of this Order, Atmos shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
  - 3. This case is closed and removed from the Commission's docket.

# RATES:

Applicable to General Sales Service Rate G-1:

### Gas Cost Adjustment

To each bill rendered under the above-named rate schedule, there shall be added an amount equal to \$4.9761 per Mcf of gas used during the billing period.

Applicable to Interruptible Sales Service Rate G-2:

# Gas Cost Adjustment

To each bill rendered under the above-named rate schedule, there shall be added an amount equal to \$3.6601 per Mcf of gas used during the billing period.
