ORDER

On May 21, 2024, Rattlesnake Ridge Water District (Rattlesnake Ridge District) filed a motion seeking an extension of time for 30 days from the original response date of May 28, 2024, to respond to Commission Staff's Eighth Request for Information (Staff's Eighth Request). Rattlesnake Ridge District stated that it needed an extension for the following reasons: (1) Staff's Eighth Request was received late Friday afternoon on May 17, 2024, and given the Memorial Day holiday, that left six working days to file the response; (2) the manager, David Gifford, who will need to sign off on the response, has a scheduled vacation beginning Friday, May 24, 2024, and the vacation was scheduled before the receipt of the current Order; (3) the information is extensive and was prior to the current manager or assistant manager being employed in their current positions and will take time to research to find or determine much of the material requested; (4) Rattlesnake Ridge District has been in the process of providing information needed for

the rate study and does not have the manpower to dedicate one employee solely to secure the new information now requested without attending to other duties.¹

The Commission finds that good cause has been shown to grant Rattlesnake Ridge District's request due to the time needed to provide a complete and thorough response to Staff's Eighth Request. The Commission notes that the continuance will not result in prejudice to any party as there are no intervenors, and there is no statutory deadline to process this case.

IT IS THEREFORE ORDERED that:


1. Rattlesnake Ridge District's May 21, 2024 motion for an extension is granted.
2. Rattlesnake Ridge District's responses to Staff's Eighth Request shall be filed on or before June 27, 2024.
