ORDER

On May 11, 2022, Laurel County Water District No. 2 (Laurel District No. 2) filed a letter seeking an extension to respond to the Commission Staff's Fourth Request for Information (Staff's Fourth Request) dated May 9, 2022. Staff's Fourth Request contained a deadline to respond of May 20, 2022. Laurel District No. 2 requested an extension until June 15, 2022, to comply with the Staff's Fourth Request. Laurel District No. 2 stated that more time was needed due to compiling information for the 2021 Annual Report, as well as compiling all the information requested in the Staff's Fourth Request.


The Commission finds that good cause has been shown to grant Laurel District No. 2's request. The Commission notes that the continuance will not affect the statutory processing of the case and that Commission Staff may issue data requests at any time if the need for more information arises during a case. However, the Commission, on its own motion, finds that the procedural schedule established on February 18, 2022, shall be amended to reflect the extension. An amended procedural schedule is set forth in the Appendix to this Order.

IT IS THEREFORE ORDERED that:

1. Laurel District No. 2's request for an extension to file responses to Staff's Fourth Request is granted.
2. Laurel District No. 2 shall respond to Staff's Fourth Request by June 15, 2022.
3. The procedural schedule set forth in the Appendix to this Order shall be followed.
4. All other provisions of February 18, 2022 Order not in conflict with this Order shall remain in full force and effect.
