ORDER

On October 27, 2021, Kentucky Frontier Gas, LLC (Kentucky Frontier) filed a Gas Cost Adjustment (GCA) rate report for its Farm Tap customers taking service pursuant to KRS 278.485 from the gas gathering systems it operates. On May 10, 2024, Kentucky Frontier filed a motion to withdraw its Farm Tap GCA rate report filing arguing that the subject matter in this case no longer addresses the relevant issues facing Kentucky Frontier¹ and the updated issues facing Kentucky Frontier will be better addressed in its upcoming rate application to be filed in 2024.

Kentucky Frontier argues that the application was filed at a time when gas costs were increasing and was specifically filed for its Farm Tap customers.² Kentucky Frontier states that since its application was filed that Kentucky Frontier has filed numerous filings with the Commission in an attempt to develop a new approach to its GCA rate reports.³ Kentucky Frontier further states that it has already begun work on a rate adjustment to be

filed in 2024 and that any changes to its Farm Tap rates would be better addressed in that rate filing.⁴

The Commission, being fully advised, agrees with Kentucky Frontier's arguments and changes to its Farm Tap rate will be addressed in Kentucky Frontier's rate filing to be made in 2024. The Commission grants Kentucky Frontier's motion to withdraw its application. Further, since the Commission grants the withdrawal of its application, Kentucky Frontier should no longer be required to respond to the April 26, 2024 Commission Staff's Second Request for Information as the subject matter of the data request will be addressed in the upcoming 2024 rate case. The Commission further finds that Kentucky Frontier should prepared to file testimony and support its proposal on the handling of its Farm Tap customers, served pursuant to KRS 278.485, in its upcoming 2024 rate case.

IT IS THEREFORE ORDERED that:

- 1. Kentucky Frontier's motion to withdraw its gas cost adjustment application of October 27, 2021, is granted.
- 2. Kentucky Frontier shall not be required to respond Commission Staff's Second Request for Information in this proceeding served on April 26, 2024.
