INITIATING ORDER FOR ALLEGED 811 VIOLATION OF THE KENTUCKY UNDERGROUND FACILITY DAMAGE PREVENTION ACT

Luxury Garden Center, Inc. (Luxury Garden Center) has been named as a party to an investigation before the Kentucky Public Service Commission (Commission) for allegedly violating the Kentucky Underground Facility Damage Prevention Act (Act).¹ A hearing in this case shall take place on September 30, 2022.

Pursuant to KRS 278.495(2), the Commission has jurisdiction to regulate the safety of natural gas facilities in Kentucky and to enforce minimum federal pipeline safety standards. Under the Act, the Commission has authority to investigate and assess civil penalties for any violation of the Act that results in excavation damage to an underground facility used to transport natural gas or hazardous liquid subject to federal pipeline safety laws, 49 U.S.C. § 60101, *et seq.* Any person who violates any provision of the Act is subject to assessment of a civil penalty in the amount of \$250 for the first offense, no more than \$1,000 for the second offense within one year, and no more than \$3,000 for the third and any subsequent offense. Additionally, any person whose violation of the Act

results in damage to an underground facility containing any flammable, toxic, corrosive, or hazardous material or results in the release of any flammable, toxic, corrosive, or hazardous material is subject to an additional penalty of up to \$1,000.

Following receipt of a report of excavation damage to its underground gas pipeline from an operator, Commission Staff (Staff) conducted an investigation and prepared an Incident Report, a copy of which is attached to this Order as Appendix A. In its Incident Report, Staff cites Luxury Garden Center for violation of the following provision of the Act:

> KRS 367.4911(1)(a) – Each excavator, or person responsible for an excavation, planning excavation or demolition work shall, not less than two (2) full working days nor more than ten (10) full working days prior to commencing work, notify each affected operator of the excavator's intended work and work schedule. Contacting the applicable protection notification centers shall satisfy this requirement.

Based on its review of the Incident Report and being otherwise sufficiently advised,

the Commission finds prima facie evidence that Luxury Garden Center violated the

Underground Facility Damage Prevention Act. The Commission further finds that a formal

investigation into the excavation damage incident shall be conducted.

IT IS THEREFORE ORDERED that:

1. Luxury Garden Center shall submit to the Commission, via email sent to <u>PSCED@ky.gov</u> with the case number of this proceeding in the subject line of the message, a written response to the allegations contained in the Staff Incident Report within 20 days of receipt of this Order.

2. Luxury Garden Center shall appear on September 30, 2022, at 9 a.m. Eastern Daylight Time, in the Richard Raff Hearing Room of the Commission's offices at 211 Sower Boulevard in Frankfort, Kentucky, for the purpose of presenting evidence concerning the alleged violation of the Underground Facility Damage Prevention Act. 3. The September 30, 2022 hearing shall be conducted via video conferencing.

4. Luxury Garden Center shall attend the hearing by using the following link: <u>https://global.gotomeeting.com/join/308551245;</u> information and instructions are attached to this Order as Appendix B.

5. Luxury Garden Center shall notify the Commission at least ten days prior to the hearing if Luxury Garden Center is unable to appear by video conferencing and will therefore appear in person.

6. Any partnership, corporation, or business entity (including a limited liability company) must be represented by an attorney licensed to practice law in Kentucky, and such representation includes the filing of papers with and appearances at hearings before the Commission.

7. An individual may submit a response to the allegations contained in the Staff Incident Report without the representation of an attorney.

8. The Staff Incident Report 42892, attached to this Order as Appendix A, is made a part of the record in this case.

9. The September 30, 2022 hearing shall be recorded by video only.

10. Please note parties who fail to appear after service will be subject to entry of a default judgment against them.

INVESTIGATION

A review of LT...1973 revealed that the Excavator obtained the ticket on 08/10/20 at 17:54 and began excavation on 08/12/20 at 13:05, 4hrs. 47min before the two day wait expiration date of 08/12/20 at 17:52.

On 06/28/21 an attempt to contact the Excavator at 270-427-6404 resulted in a message stating you have reached Luxury Garden Center, Lacey, wherein a message was left.

The following occurred on 06/29/21:

An attempt to contact the Excavator at 270-678-5555 resulted in a message stating you have reached Luxury Garden Center wherein a message was left.

Kevin Kerr (270-427-6509) of Luxury Garden Center stated that the area was marked and due to the markings he began to dig.

Via telephone the Operator, Atmos's Anthony Stallins stated that no markings were place prior to the damage, any markings present were placed after the damage occurred.

A call back to Mr. Kerr resulted in Mr. Kerr stating the markings were present before the damage occurred.

On 07/12/21 Mr. Stallins provided the following:

- <u>Show Compliance/Construction Order Details report</u>: Indicating the Excavator damaged an unmarked ³/₄ inch service, with a trencher, while landscaping and was excavating during the two day wait period. Ticket not ready until 08/12/20 at 5pm.
- <u>3 Photographs:</u> Depicting a trencher, the unmarked line and the damaged pipe. Note: On the incident date white paint was used to identify the path of the unmarked service.

Atmos's report and photographs are include as Attachment 3.

On 07/13/21 a follow up call to Mr. Kerr resulted in a voice message being left.

On 07/15/21, via email, Mr. Stallins stated that the Excavator paid Atmos \$499.84 for the damage associated with this incident. Mr. Stallins also provided the Invoice and the Third Party Damage Claims Recovery letter. **The Email, Invoice & Letter are include as Attachment 4.**

On 07/19/21 a follow up call to Mr. Kerr resulted in a voice message stating he was out until 07/27/21 and to call 270-678-5555. A call to 270-678-5555 resulted in a voice message being left informing the forthcoming Demand Letter imposing the penalty of \$250.00 and the Damage Prevention course.

(b) An excavator may commence work before the two (2) full working days provided for in paragraph (a) of this subsection have elapsed if all affected operators have notified the person that the location of all the affected operators' facilities have been marked or that they have no facilities in the area of the proposed excavation, demolition, or timber harvesting.
