ORDER

On March 14, 2022, the Kentucky Power Company (Kentucky Power), filed a motion requesting Commission approval for Chad M. Burnett to participate virtually in the March 28–29, 2022 hearing. As a basis for the request, Kentucky Power explained that Mr. Burnett has a previously scheduled in-person event in Louisiana on March 29, 2022, and that travel from his home state to Kentucky and then to Louisiana creates logistical difficulties. Kentucky Power stated that Mr. Burnett’s involvement in this matter is minimal, explaining that Mr. Burnett did not file testimony and sponsored responses to a total of five discrete data request questions from two of the parties. Kentucky Power further stated that Mr. Burnett would participate in a test of technology, and that the remaining Kentucky Power witnesses will appear in person.

Based upon the motion and being otherwise sufficiently advised, the Commission finds that Kentucky Power established good cause to grant the motion for Mr. Burnett to participate virtually in the March 28–29, 2022 hearing. Before the hearing date, Mr. Burnett shall conduct a test of technology with Commission Staff to ensure that counsel’s audio and video capabilities are sufficient.

IT IS THEREFORE ORDERED that:

1. Kentucky Power's motion for Chad W. Burnett to participate virtually in the March 28–March 29, 2022 hearing is granted.

2. Commission Staff shall contact participants with instructions for conducting a test of technology and participating remotely in the hearing.
