ORDER

On March 11, 2022, the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General), filed a motion requesting Commission approval for Lawrence W. Cook to participate virtually in the second day of the March 28–29, 2022 hearing, due to health reasons. Mr. Cook stated that he will participate in person on the first day of the hearing, and that John G. Horne II and J. Michael West will participate in person both days of the hearing. Additionally, Mr. Cook stated his virtual participation will not prejudice the Commission or any other party.

Based upon the motion and being otherwise sufficiently advised, the Commission finds that Mr. Cook established good cause to grant the motion to participate virtually in the March 28–29, 2022 hearing. Before the hearing date, Mr. Cook shall conduct a test of technology with Commission Staff to ensure that counsel’s audio and video capabilities are sufficient.

IT IS THEREFORE ORDERED that:

1. The Attorney General’s motion for Lawrence W. Cook to participate virtually in the March 28–March 29, 2022 hearing is granted.

2. Commission Staff shall contact participants with instructions for conducting a test of technology and participating remotely in the hearing.
