ORDER

A hearing in the above-styled matter was held on March 28, 2022, and March 29, 2022. At the conclusion of the witness testimony, Staff and several parties requested to file post-hearing data requests and counsel for the parties requested to file post-hearing briefs after responses to data requests had been filed.

IT IS THEREFORE ORDERED that:

1. Post-hearing data requests, if any, shall be filed on or before March 31, 2022.
2. Responses to post-hearing data requests shall be filed on or before April 8, 2022.
3. Parties shall file simultaneous memorandum post-hearing briefs on or before April 12, 2022.
4. Kentucky Power Company, Liberty Utilities Company, and American Electric Power Company, Inc. (Joint Applicants) shall file the Bridge Power Coordination Agreement (Bridge PCA) on or before April 12, 2022.

5. Parties shall file simultaneous response briefs on or before April 18, 2022.


The Intervenors may address the Bridge PCA in their response briefs.

6. Joint Applicants may file a reply brief on or before April 21, 2022, solely responding to arguments regarding the Bridge PCA.

7. This case shall stand submitted for a decision by the Commission effective 12:01 a.m., Eastern Daylight Time, on April 22, 2022.
