ORDER

On March 8, 2022, the Sierra Club filed a motion to participate virtually in the March 28, 2022 through March 29, 2022 hearing in this matter. As a basis for this request, the Sierra Club noted that there is still a prohibition on work-related travel by staff due to the ongoing COVID-19 pandemic. Sierra Club noted the fact it will not be presenting any witnesses at the hearing. Additionally, Sierra Club stated its virtually participation will not prejudice the Commission or any other party.

Based upon the motion and being otherwise sufficiently advised, the Commission finds that Sierra Club established good cause to grant the motion for counsel to participate virtually in the March 28, 2022 through March 29, 2022 hearing. Before the hearing date, counsel for Sierra Club will conduct a test of technology with Commission Staff to ensure that counsel's audio and video capabilities are sufficient.

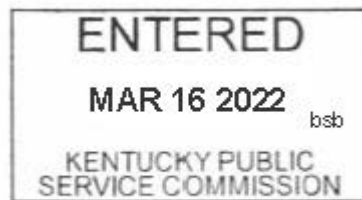
IT IS THEREFORE ORDERED that:
