Pursuant to Staff Notice issued on December 6, 2021, an informal conference (IC) was conducted on January 7, 2022. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss issues pertaining to Hyden-Leslie District's tariff filing, particularly Rule 11(j), Rule 3(b), the photo ID requirement, and Rule 9(d). After a discussion of the issues, Mr. Wuetcher agreed to present alternative language for Rule 11(j) to the District's board, and to inform Tina Fredrick of the results during the week of January 10, 2022.
