State the nature of your concern: We own, live on, and operate a 65-acre farm in Mason County, KY. We are opposed to any construction of an industrial solar electric generating factory on prime farmland in our community. We believe that if such a facility is built, the obvious collateral damage caused mainly by the construction would result in major negative impact on our way of life in the rural area we love so much. Damage to our narrow county roads, culverts, and bridges would be inevitable. The wildlife in our area would certainly be decimated due to the disruption and destruction of habitat, mainly by the fencing built around the solar facilities. And finally, common sense supports our concern that the property value of our farm which has been in our family for nearly one hundred years would be drastically

reduced, likely by at least 25 to 30%. Like what we believe is a majority of farm owners, other property owners and residents of our community, we don't believe in the promises of big money payoffs to farmers or other concerns such as our schools. If the solar developers are permitted to proceed with construction, our final plea is to maintain current KY State Statue provision setbacks of 1,000 feet from adjoining property lines and 2,000 feet from residences and or neighborhoods.
