The Commission Staff has reviewed the application in the above case. This filing is rejected for the reasons set forth below.

Filing deficiencies pursuant to:

- (1) 807 KAR 5:001, Section 16(7)(o): Complete monthly budget variance reports, with narrative explanations, for the 12 months immediately prior to base period, each month of base period, and subsequent months, as available; Provided reports for June 2020 May 2021. The base period is Oct. 2020 Sept. 2021, so reports should be for Oct. 2019 May 2021.
- (2) <u>807 KAR 5:001, Section 16(8)(n):</u> Typical bill comparison under present and proposed rates for all customer classes; Due to presentation of customer classes not aligning with rate schedules. In addition, calculation should be based off of present and proposed rates in the notice.
- (3) <u>807 KAR 5:001, Section 17(4)(b)</u>: The present and proposed rates for each customer class to which the proposed rates will apply; Base charge for residential customers is not a per mcf charge. In addition, a note should be added to the present rates column indicating that the charges include the applicable Pipeline Replacement Program charges.
- (4) <u>807 KAR 5:001, Section 17(4)(c)</u>: Amount of change requested in dollar amounts and percentage change for each customer classification to which change will apply; Due to presentation of customer classes not aligning with rate schedules.
- (5) <u>807 KAR 5:001, Section 17(4)(d)</u>: Local exchange companies include effect upon average bill for each customer class for change in basic local service; Due to presentation of customer classes not aligning with rate schedules. In addition, calculation should be based off present and proposed rates listed in the notice.

You are requested to submit the information necessary to cure the deficiencies within 20 days of the date of this letter.
