**RE:** Informal Conference of August 17, 2022

Pursuant to Staff Notice issued on August 17, 2022, an informal conference (IC) was conducted on August 17, 2022. Attached is a copy of the attendance roster.

The purpose of the IC was to identify factual issues in dispute and to discuss an expedited schedule to conduct pre-hearing discovery.

Counsel for East Logan Water District (East Logan District), Gerald Wuetcher, expressed his client's position that parties be allowed to conduct 2 rounds of pre-hearing discovery. Mr. Wuetcher said his client favors broad discovery to identify all issues between the parties.

Counsel for Logan Telephone Cooperative, Inc. (Logan Telephone), Chris Zelli, said his client favors one round of discovery limited to the underground facility locate requests submitted by Logan Telephone or its contractors to East Logan District, East Logan District's responses to these locate requests, and its compliance with the Underground Facility Damage Prevention Act of 1994 (Damage Prevention Act).

The parties support exchange of witness lists that indicate the subject of each expected witness's hearing testimony. The parties support the first round of discovery be due within 14 days after service of the scheduling order and responses thereto due within 14 days thereafter.

There being no further discussion, the IC was then adjourned.
